

Recess Duty Paid Subs for the 2016-17 School Year

The parents or legal guardians of each student registered in kindergarten-8th grade are required to fulfill up to 6 hours of Recess Duty per family. In the event you have a schedule conflict, you may contract with a Paid Recess Duty Substitute to fulfill your shift(s). For your convenience, you will find a list of those parents who are happy to fill in as paid subs. The list is made available to you as both a table and an email “blob” which you can cut and paste into your email TO: field.

The substitute fee is \$20, to be paid directly to the substitute.

If you/your substitute fail(s) to show up on your assigned day, you will be fined a \$40.00 “NO SHOW” fee, payable to the Holy Spirit PTO.

If you hire a substitute or trade with another parent, please be sure to remind that person when the time approaches, so as to avoid a fine.

Please remember: NO small children at Recess Duty.
